What is a Registry?

- Listing of qualified individuals who continually demonstrate their competency in a specialty area
- Through application and competency assessment, registry programs verify an individual's knowledge and abilities in a specialized area of practice
- Assure a level of quality among professionals



SDS Competency Assessment

Two part, four hour exam

- Part 1 General Knowledge Updated
 2017
 - 75 multiple choice questions
 - Based on the current BoK (2016)
- Part 2 Skills Assessment No change
 - Substance classification, mixture classification, SDS development



SDS Competency Assessment

Updated Study Guide released May 2018

- AIHA's education department is working with SMEs to develop the companion education, expected end of October 2018
- Credentialing industry standards require a firewall between test development and education to support the credential



SDS & Label Authoring Registry

Program Overview

- 79 Registrants
- Assessments Delivered since Revision
 - 17 (part 1); 16 (part 2)
- AIHA Registry Programs continues to review and evaluate the performance of each question
- It is a challenging, but passable, exam!



Be a Registry Ambassador

As an individual:

Talk to colleagues about the SDSRP – you earned it, own it!
 Think about the impact on your career – it's the only credential in this area of practice.

As a Manager:

 Encourage your authors to gain the knowledge, skill, and experience. Support education efforts and their drive to attain the designation. Be a driver!

As a Company:

 Recognize the SDSRP on staff. Use SDSRP in marketing your organization as a way to set you apart from competitors, or in your internal continuous improvement activities. Coordinate a group testing session!

Requires affirmation to updated <u>Guidelines for Use</u> of <u>SDSRP Designation</u> by current Registrants



Registration Renewal Options

There are now **two** way to maintain your SDS and Label Authoring Registered Professional credential.

Re-assessment

- Successfully retaking the two Part examination
- Assessment fee
- Remote proctoring available, for additional fee

Renewal

- Obtaining 10 renewal points over the 5-year registration cycle
- Renewal fee (\$100)

Annual Registration Fee

- Remains only \$50/year
- Ensure your email address is current
- Invoicing for will occur in the new database

- AIHA Registry Programs is moving to a new candidate management database

- Quicker turnaround time
- Launching by the end of 2018









Online Testing and Remote Proctoring

- Secure and still proctored
- Better analytics
- Greater flexibility in scheduling
- Can be made available outside the US
- Easy group testing
