



EPA Expediting Emerging Viral Pathogens Claim Submissions

The U.S. Environmental Protection Agency (EPA) has contacted registrants of disinfectants who have products that may be effective in killing the coronavirus. The agency is expediting the review of submissions from companies who are requesting emerging viral pathogen claims to their already-registered surface disinfectant labels. According to EPA Administrator Andrew Wheeler, “By prioritizing these reviews, we are ensuring that Americans will have access to all approved and market available surface disinfectant products.”


March is National Ladder Safety Month

TSCA Updates and March TSCA Inventory List

The Toxic Substances Control Act (TSCA) Inventory List was updated this month. Download the [latest TSCA Inventory](#).

On February 19th, 2020, [EPA finalized a rule](#) on the procedures for companies to substantiate their confidential business information (CBI) claims for the specific chemical identities of substances on the TSCA inventory, as well as the plan for how the Agency will review the claims, timeframes and the annual posting of results. The [rule](#) includes questions about reverse engineering. CBI reviews covered in this rule must occur before February 19, 2024.

On February 26th, 2020, [EPA issued](#) a final list of 20 chemical substances designated as [low-priority substances](#) for which risk evaluation under the TSCA is not warranted at this time. Read the [supporting information](#) about the low-priority substances.

On March 13, 2020, [EPA announced](#) that it has extended the deadline to self-identify as a manufacturer or importer of a high-priority chemical to May 27, 2020. Use this link for a [list of the chemical substances undergoing prioritization](#).

ECHA Committees Conclude on Five Restrictions

The Committee for Socio-economic Analysis (SEAC) and the Committee for Risk Assessment (RAC) [release](#) shared information about the following:

- SEAC adopts final opinion to follow ECHA's proposal to restrict placing D4, D5 and D6 as substances in the market.
- SEAC agreed on its draft opinion on ECHA's proposal to restrict the use of five cobalt salts as substances on their own or in mixtures. RAC adopted its opinion on this restriction in February 2020.
- RAC adopts its opinion on France and Sweden's proposal to restrict skin sensitizing substances in finished textiles, leather, hide and further articles, placed on the market for the first time. Agreement on the SEAC draft opinion is postponed until June 2020.
- RAC and SEAC support Norway's proposal to restrict PFHxS (linear or branches)
- SEAC supported ECHA's proposal to restrict formaldehyde.

Agreements were not met regarding microplastics and discussions will continue in June. The release shared additional adoptions, which can be found in the [Annex](#).

ECHA Adopts 14th ATP

In October of 2019, the European Commission [adopted the 14th Adaptation to Technical Progress \(ATP\)](#) to the Classification, Labelling and Packaging (CLP) Regulation. The adoption included Annexes II, III and IV. The act was put forth to the European Parliament and the Council of Ministers. One controversial topic in the proposed amendments regarded titanium dioxide. This chemical is used widely across multiple industries and in a range of product types. In January, the European Parliament rejected the opposition regarding titanium dioxide's classification, and on February 18, 2020, the European Commission published the [regulation](#) with the classification. It will enter into force after 20 days, and harmonized classifications will apply from September 9, 2021.



California Proposition 65: Acetaminophen

California's Office of Environmental Health Hazard Assessment (OEHHA) is considering listing acetaminophen as a carcinogen under Proposition 65. The public comment period is TBD as the Carcinogen Identification Committee has scheduling challenges posed by COVID-19.
