SCHC Fall Meeting 2020

Our first ever virtual Fall meeting is fast approaching, and we have an exciting line up of speakers & topics for both days. OSHA will kick off Day 1 when Maureen Ruskin and Sven Rundman will present on 3 topics; “Safe + Sound”, “OSHA’s Response to COVID-19” and “Revision to the Hazcom Standard”. This will be followed by Lynn Berndt-Weis from Health Canada who will give an overview of WHMIS and GHS in Canada. From there we will move to the other side of the world where Robert Kiefer of REACH24H will give us the latest news on Asia Pacific hazcom and chemical control. Then, to complete our world tour, we move to Europe where Christine Lepisto of Chemical Safety Consulting in Germany will explain the REACH Annex II safety data sheet changes. The regulation of Endocrine Disruptors is a topic growing in importance in many countries and Robert DeMott of Ramboll US Corporation will enlighten us about this subject.

How do you assess the hazards of chemicals if you have no test data? Well, Marisa Kreider of Cardno ChemRisk will start Day 2 by discussing the Evidence Integration Approach as one way to accomplish this. What about chemicals that have no specific Occupational Exposure Limits (OELs)? T.J. Lentz from NIOSH will discuss NIOSH Occupational Exposure Banding which groups chemicals based on toxicological potency and adverse health effects associated with exposure.

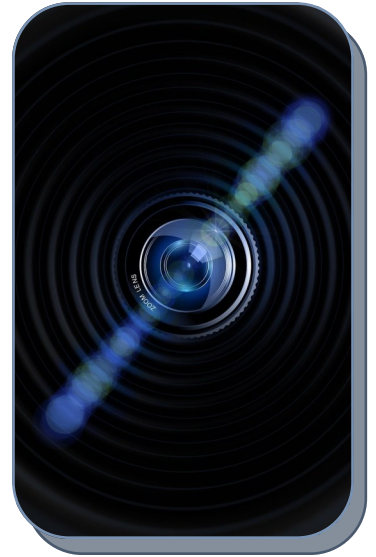
CA Prop 65 - Notice of Intent for Molybdenum Trioxide & Indium Tin Oxide

New CA Prop Fact Sheet for Flame Retardants

CA Prop 65 – Notice of Intent for Molybdenum Trioxide and Indium Tin Oxide

California’s Office of Environmental Health Hazard Assessment (OEHHA) released a [Notice of Intent](#) to add molybdenum trioxide (CAS No. 1313-27-5) and indium tin oxide (CAS No. 50926-11-9) as known agents to cause cancer. The action is pursuant to the Labor Code mechanism under California Labor Code section 6382(b)(1). OEHHA has opened a comment period which will close on November 23, 2020, which was extended an extra 15 days because of the pandemic.

As this falls under a Labor code, the comments are restricted to whether the International Agency for Research on Cancer has identified the specific chemical or substance as a human or animal carcinogen. Arguments regarding weight or quality of the evidence are not being heard.



New CA Prop 65 Fact Sheet - Flame Retardant

In July, California’s Office of Environmental Health Hazard Assessment (OEHHA) [shared a new Fact Sheet](#) regarding flame retardants. Flame retardants are used in a variety of consumer products to reduce their



flammability. Some of the known flame-retardant chemicals are known to cause cancer: Antimony trioxide, chlorinated tris(1,3-dichloro-2-propyl) phosphate, TDCPP, and TDCIPP), pentabromodiphenyl ether (PentaBDE) mixture [DE-71(technical grade)], tetrabromobisphenol A (TBBPA), and Tris (2-chloroethyl) phosphate (TCEP).

The chemicals are used on upholstered furniture, carpet, carpet padding, motor vehicle interiors, electrical and electronic products, building insulation, and camping tents and gymnastics equipment. California has created a ban that begins in January 2021 regarding use and amount. [New Fact Sheet](#)

New Restriction Intentions for BPAs & PFAS

ECHA shared the news that Germany has issued an [intention to restrict](#) and place on the market and use of 4,4'-isopropylidenediphenol (bisphenol A; EC 201-245-8, CAS 80-05-7) and 'structurally related bisphenols of similar concern for the environment. Bisphenol A (BPA) has been identified as an endocrine disruptor.

Much like in California, fire-related chemicals are being reviewed in Europe. ECHA has submitted an [intention to restrict](#) per- and polyfluoroalkyl substances (PFAS) in firefighting foams. Data collected in Europe shows that fluorinated fire-fighting foams contaminate the soil and drinking water.

Both intentions were submitted in October 2020 and restricted proposals are expected October 2021.

On October 29, 2020, there is an upcoming [ECHA Webinar: Restriction of per- and polyfluoroalkyl substances \(PFAS\) under REACH](#) that shares information about the REACH restrictions process and status of the proposed PFAS restriction. The event will include a live Q&A session.

Restricting 1,000 Skin Sensitizing Substances

The Committee for Socio-economic Analysis (SEAC) has adopted its [final opinion](#) on France and Sweden's [proposal](#) to restrict [skin sensitizing substances](#) in clothing textiles, leathers, and synthetics placed on the skin. Skin sensitization is a health effect that leads to a lifelong sensitive to a specific allergen and it is estimated that up to 5 million people in the European Economic Area are already sensitized and nearly 180,000 new cases are added each year. The proposed restriction covers substances that have a harmonized classification as skin sensitizers under the Classification, Labelling and Packing (CLP) Regulation. If the European Commission adopts the restrictions many new skin allergies will be prevented and existing symptoms relieved for those currently impacted.
