TWO PUBLIC MEETINGS ON AMENDED TSCA IMPLEMENTATION

EPA is holding two meetings in December to discuss ongoing implementation activities under the Frank R. Lautenberg Chemical Safety Act, which amended Toxic Substances Control Act (TSCA). This follows up on Administrator Scott Pruitt's pledge for greater transparency and continued stakeholder engagement as the Agency implements provisions of the amended TSCA.

December 6, 2017: Public Meeting on New Chemicals: The first meeting is to update and engage with the public on the Agency's progress in implementing changes to the New Chemicals Review Program as a result of the 2016 amendments to TSCA, including discussion of EPA's New Chemicals Decision-Making Framework. EPA will describe its review process for new chemicals under the amended statute, and interested parties will have the opportunity to provide input on their experiences with the New Chemicals Review Program since the statute was amended and to ask questions. In addition, EPA will accept questions from the public in advance of the meeting, and will respond to these questions at the meeting as time allows. December 11 Public Meeting on Approaches for Identifying Potential Candidates for **Prioritization for Risk Evaluation:** The second meeting will focus on possible approaches for identifying potential candidate chemicals for EPA's prioritization process under TSCA. As amended, TSCA required that EPA establish processes for prioritizing and evaluating risks from existing chemicals. EPA will describe and take comment on a number of possible approaches that could guide the Agency in the identification of potential candidate chemicals for prioritization. In addition, EPA will accept questions from the public in advance of the meeting, and will respond to these questions at the meeting as time allows. Delay to the Electronic Reporting Requirements of the Improve Tracking Rule Hi Everyone,

As part of our efforts to keep you informed of OSHA's activities, I wanted to let you know that OSHA has issued a final rule to a delay the electronic reporting compliance date of the Improve Tracking of Workplace Injuries and Illnesses rule, from July 1, 2017 to December 15, 2017. The delay provides employers the same four-month window for submitting data that the original rule would have provided.
